Crime Policies, Procedures & Reporting

Campus Safety Report: In accordance with the Crime Awareness and Campus Security Act, CBT College presents this campus safety report. - Meeting with program directors and instructors at the end of every term. At this time we discuss what procedures are for reporting as well as preventing crime on campus.

- Providing safety webinars or class every term, to inform members of the college community about their need to be responsible for their own security, including locking doors, crossing campus, etc.
